A single parent's circumstance entails greater duties, ranging from finances to the home and children. They may have to multitask during the day, and their efforts will have to be quadrupled to keep the children's education and lifestyle up to date. When a lonely mother has a low income, some children may be upset about the family circumstances and acquire negative emotions, as well as becoming worried or aggressive over time.

In this context, Mrs.N.Usha, a single mother from Chennai, approached Hurricane Vets Charitable Trust, requesting educational assistance for her son due to her poor monthly income. Dr.G.Kathiravan, a member of HVCT, and Dr.R.Manivannan, Professor and Head, Department of Veterinary Extension, Madras Veterinary College, stepped forward to help the school boy after hearing about the family's condition.

After carefully reviewing the situation, the Board of Trustees, HVCT agreed to provide educational support to the son of Mrs.N.Usha and accepted the request.
