In order to meet out the rising demand for milk and dairy products, Thirumala Milk Products Pvt. 
As part of this initiative, a comprehensive training programme was conducted on May 10th, 2025 at Aarani, Thiruvannamalai District organized by the Hurricane Vets Charitable Trust (HVCT), Chennai, the session aimed to enhance dairy farm productivity and to improve farmers income.

In the training programme, farmers were informed about the benefits of the loose housing system for dairy animals, highlighting its role in reducing construction costs. This system also supports the 'happy animals' concept by

Dr. S. Jeyabal elaborated on the nuances of low-cost dairy farming, offering valuable insights into practical approaches. This was followed by an engaging main technical session presented by Dr. M. Ganesan. Dr. C. Theophilus Anand Kumar then provided detailed clarifications, addressing queries and enhancing participants' understanding of the discussed topics.

The importance of adequate drinking water for dairy animals was emphasized, as it plays a vital role in milk production, digestion, and overall health. Lactating cows need plenty of clean water daily. Insufficient intake can lower milk yield and cause health problems, affecting productivity and animal welfare on the farm. The use of herbal medicine to reduce the cost of milk production was emphasized as a significant aspect of the training programme. Herbal remedies offer a natural and cost-effective alternative to conventional veterinary treatments, helping to improve animal health and productivity without the high expense of commercial drugs. By incorporating herbal solutions into daily farm practices, farmers can lower their input costs, enhance milk yield, and promote sustainable and eco-friendly dairy farming methods that benefit both animals and farmers.

Around 56 farmers attended the programme, detailed technical а presentation was given by Dr.M.Ganesan, Member, HVCT. The technical session lasted nearly three hours and was followed lively discussion, engaging showcasing the farmers' enthusiasm and willingness to adopt improved dairy farming practices. Initially, Dr.S.Jeyabal, Head of Agro Services, Thirumala Milk Products Pvt. Ltd., Chennai , gave an overview of the training session and answered various queries of the farmers. Dr.S.Vigil Anbiah, Secretary of HVCT, introduced HVCT to the trainees and explained how this professional team could support farmers with low cost technologies to boost milk production. He also emphasized the importance of tracking farm income and expenses, introducina an android application available in the play store to help farmers to take decisions and identify areas for improvement. Dr.C.Theophilus Kumar, EC Member of HVCT, provided insights into animal diseases and outlined key symptoms that indicate health issues. He encouraged the farmers to reach out to VCRI, Salem, TANUVAS for any technical support to improve their farm outcome.
